Dear Parents/Guardians,

It is time to plan for next year! Enclosed is the re-registration packet for the 2023-2024 school year. Please complete the re-registration forms and return to the school office by January 31, 2023 with the registration payment of \$350.00.

If you register by January 31, 2023, there will be no increase in tuition/fees. That is an incentive for all those that wish to not have an increase. Please return paperwork with a check or cash. Please adhere to the due dates stated below. The registration fee secures your student/s space for the 2023-2024 school year.

We have an amazing school and there are so many great things happening at our school! First and foremost, we truly care about your children. We work tirelessly to ensure that they are safe, happy, and healthy. We have a strong academic curriculum, our Catholic faith is infused into every aspect of our day, a beautiful enclosed campus, routine emergency drills each month, and teachers who are the heart of our school. Please help us to spread the news about our wonderful school. We need to increase enrollment in order not to have any increases in tuition and fees. Spread the word about Open House, our school, daily tours, and let people know why you send your child/ren to St. Luke Catholic School!

If you have a new student enrolling this fall, please check the appropriate square on the attached re-registration form and an application will be sent home with your oldest child. Transitional Kindergartners should be 4 years old by September 1, 2023, Kindergartners should be 5 years old by September 1, 2023 and First Graders should be 6 years old by September 1, 2023. Please talk to Ms. Jefferys for exceptions.

If your student/s will not be returning in August, please return the enclosed re-registration noting that the child/ren will not be returning.

Please attach a copy of your 2022-2023 school year contributions. These need to be requested by you, from St. Luke Church, and attached to your re-registration forms. You need to request this from the Parish Office. This will be used for verification of your \$380+ contribution as a supporting member of St. Luke Parish, to receive the supporting tuition rate.

VIP Credits can be bought out at a rate of \$30 per VIP Credit.  $24 \times 30.00 = 720.00$  for two parent families and  $16 \times 30.00 = 480.00$  for single parent families. A Single Parent Family means that the child never sees the other parent, and that that parent is not in the child's life at all. Fiesta hours cannot be bought out; unfulfilled Fiesta/Family Fun Day hours will be billed at \$50 each; the requirement is 6 hours per family/4 for single parent families.
